For the past decade, I have taught graduate students seeking knowledge and skills in qualitative research to enable them to successfully complete a thesis in programs of study leading to M.A. and Ph.D. degrees. 13. KNOWLEDGE MOBILIZATION VIA NON-TRADITIONAL MEDIA

In December 2024, TELUS Optik TV will begin broadcasting a nine-episode series (total running time of 225 minutes) of documentary films that I wrote, directed and produced. The series is entitled, "Latinas' Diary: A Jouney of Strenght, Hope, and Empowerment." Production was funded by TELUS and supported by in-kind contributions of technical support (post-production editing) from the Institute for Social Research, UNAM.

In September 2023, the Casa Mexico Foundation sponsored an exhibition of my research as part of the Latin American Arts and Culture Festival held at C-Space in Calgary. 14. ACADEMIC LEADERSHIP

From March 2019 through May 2021, I served as a member of the Academic Council of the Institute for Social Research at the National Autonomous University of Mexico. The Institute has nearly one hundred tenured sociologists, and is one of the most prestigious sociology departments in the Spanish-speaking world. As an Academic Council member, I contributed to collegial governance and decision-making regarding all aspects of the academic roles – research, teaching, and service – of faculty members in the Institute.
